Location/Directions:

Matson Hill Park- From Hwy 40/94 interchange, follow Hwy 94 South past Defiance. Right on Matson Hill Road.

Klondike Park- From Hwy 40/94 interchange, follow Hwy 94 South approximately 14 miles through Defiance and past Matson. Park entrance is on left side of Hwy 94.

Indian Camp Creek Park- From Hwy 40-61/70 Interchange, follow Hwy 61 North past State Rd. W, at the bottom of the hill turn left on Dietrich Rd. Park entrance on right.

Quail Ridge Park- From Hwy 70, exit onto Hwy 40/61 South. At Prospect Rd., turn right. Then make a right on Duello Rd. Follow until you see park entrance on left.

**Race #2 - Klondike Park

**Race #3 - Indian Camp Creek Park
(10M) Oct. 23 at 9 AM**

The first 125 pre-registered participants will receive a different giveaway item at each race.

In each race, certificates will be given to the top three male and female finishers in five-year age groups.

One male and one female overall series winner, as well as one male and female per age group, will be awarded trophies based upon total accumulated points. To be eligible, participants must complete Race 4 and at least two of the other three races.
